SUBJECT: AN APPLICATION FOR A VARIATION OF A PREMISES LICENCE IN RESPECT OF THE NEPTUNE PUBLIC HOUSE AND HOTEL, 127 HYTHE ROAD, DYMCHURCH, TN29 0TS

SUMMARY: This sets out the facts for the Licensing Committee to consider in determining a variation of premise licence. The licensing committee is the Licensing Authority acting in a role previously taken by the Magistrates Court. It is, therefore, not appropriate for officers to make additional comments other than in the capacity as a Responsible Authority under the legislation of the Licensing Act 2003. Therefore there are no comments from Legal, Finance or other officers included in this report

REASONS FOR DETERMINATION:

The Committee is obliged to determine the application with a view of promoting the licensing objectives. In making its decision the Committee must also have regard to all the representations made and the evidence it hears. The Committee is obliged to have regard to the national guidance and the councils own licensing policy.

DETERMINATION:

The Licensing Sub-Committee is asked to:

- 1. Note the contents of Report DCL/17/18
- 2. Determine the application. The options for determining the application are set out in section 5 below.

1. BACKGROUND

- 1.1 The Licensing Act 2003 provides that the sale or supply of alcohol on and off the premise and other licensable activities must be authorised by a premise licence.
- 1.2 The premises does have a current premises licence.
- 1.3 A copy of the application is enclosed as Appendix 1.
- 1.4 The premises are situated at 127 Hythe Road Dymchurch. It is set back from the A259 with a car park at the front and predominantly privately owned residential accommodation to the west. To the east and rear are holiday caravans and chalets belonging to the licence holder operating as "New Beach."
- 1.5 Current licence details (where appropriate) are enclosed in Appendix 3.

2. APPLICATION

- 2.1 An application has been made for a Variation of a Premises Licence by the licence holder Park Holidays UK Ltd
- 2.2 The application is in relation to The Neptune Public House and Hotel, 127 Hythe Road, Dymchurch.
- 2.3 The application is for to extend the sale of alcohol, recorded and live music Monday to Saturday 0900 to 0300 the following morning, Sunday 0900 to 0200 the following morning; late night refreshment Monday to Saturday 2300 to 0300 the following morning, Sunday 2300 to 0200 the following morning; opening hours to be extended Monday to Saturday 0900 to 0330 the following morning, Sunday 0900 to 0230 the following morning. Also to add non-standard timings for British Summertime and New Years as per the application.
- 2.4 The applicant is mindful of their responsibilities and has received copies of the objections (see Appendix 2). The applicant has not indicated that they will be making any additional steps to promote the licensing objectives.

my property is less than 400 hundred yards from Neptune holiday camp as the crow flies my wife and I are a against the licence as it is too close with cars and noise music at 0900 to 0300 hrs Monday to Saturday Sunday 2300 to 0200 hrs Dear Sirs,

I am registering my objection to the extending premises opening hours as detailed in the change of licensing application put forward by the owners and management of The Neptune Public House. I live in Marine Avenue.

As I understand it, they wish to extend the hours that they are permitted to sell alcohol, sell food and have music so it will be near enough all day every day.

There are several reasons for my objections to these proposed extended opening hours: 1) the noise levels, from both music and patrons, every night until the small hours will become intolerable very quickly, particularly during the summer and will be an unrelenting intrusion for people residing close by and who have to go to work early most days of the week. Are we expected to keep windows shut to keep the noise in the height of summer in order to get a decent night's sleep? Not only that, but there will no doubt be the noise of patrons leaving in the small hours and after a skin full of alcohol, they will not be leaving as quietly as church mice at that time. Having lived next door to the Kings Head in Hythe, kicking out time at 11pm was bad enough each evening, but to have the process at 3.30am 6 nights a week shows no consideration for the those living nearby. 2) Late night opening encourages more binge drinking, not less. There has been vandalism already of bus shelters and telephone box, and those living close by have reported being on the receiving end of drunken behaviour. There are 2 further considerations with regard to safety - the likelihood of increased work for the already overstretched emergency services and the likelihood of some taking their chances by going into the sea. Again, if they get into difficulties, it will impinge on stretched resources.

3) Public transport will not be running at that time, so those attending will more than likely be driving, therefore there is the real possibility of those leaving being over the limit when leaving the venue. The A 259 is notorious for having accidents on the double bend just before the shooting ranges going towards Hythe, and it is not unknown for drivers to think the speed limit is well over 40mph and overtake recklessly as it is. The late opening will probably, albeit, indirectly encourage drink driving because of the lack of public transport and exorbitant costs of taxis after midnight. There will those that will drive recklessly because they will want to get home and there will be more accidents on this stretch of the A259 as a result. Aside from the disruption that causes to others driving to and from Hythe and Dymchurch, and beyond, it impacts on emergency services, either because they are attending, or because they are unable to get to other emergencies in the district.

Therefore, in conclusion, I do not think the opening hours should not be increased at all for the reasons cited above. Furthermore, the lack of consultation by the management of the Neptune show the lack of consideration they have for the local residents, and it therefore clear that they are putting profit before the needs of the community to live in area that is safe throughout the year.

We have read the notice placed on the lamp post outside our property at 121-122 Hythe Road, Dymchurch, TN29 0TS and are writing to make known our objection to the proposed extension of the licence at the Neptune premises for the sale of alcohol, food, recorded and live music.

The notice states that the licencee is seeking to extend opening hours by 30 minutes, closing at 03:30 instead of 03:00 Monday to Saturday, and 02:30 instead of 02:00 on Sundays, however, having checked the details of the licence history on Shepway's website, it would appear that the current licence for alcohol sales and recorded music only covers the hours of 11:00 to 00:00.

Over the past 30 years that we have lived at this address, the Neptune has held very occasional events involving live music and although this does cause a disturbance to immediate neighbours, it has been only very occasional.

The prospect of a permanent licence for alcohol sales and live music all year round until 03:30 is completely unthinkable since it will have a detrimental effect on our ability to sleep as we have to go to work in the mornings. Furthermore, we occasionally have drunk holiday makers wandering up our drive or even entering our garden and cannot imagine this happening in the early hours of the morning as the licence extension implies.

We understand that The Neptune is now owned by a multi-million pound company who runs other caravan parks in the country, however, this one is far too close to private properties to permit this type of activity without causing huge disturbance and distress to its occupants such as us who have been living here for many years in peace. It would be a different thing if the park owners were to request such a licence for a club house in the centre of its own site where only their own patrons would be affected by drunk holiday makers and loud live music until early morning.

Unfortunately, as things are, The Neptune is adjacent to private properties with no buffer against the loud noise of live music and revellers. Furthermore, this would have a detrimental effect on the value of these properties, should any of us wish to sell up to remove ourselves from the potential problems brought by longer licence hours and activities.

We therefore object most strongly to the variation of this licence as requested by the licencee.

Reasons: Due to the proximity of residential properties and the proposed longer opening hours to include live and recorded music, which are Monday – Saturday to 03:00hrs and Sundays to 02:00hrs, there is high risks of a public nuisance to occur.

Should the license be granted Environmental Health would recommend the following conditions:

- Opening hours: Monday Saturday: 01:00hrs Sunday: 00:00hrs
- All doors and windows closed during live performances.
- Music must be periodically checked outside of the premises for possible noise disturbance to nearby residential properties. This must be carried out by a competent person, with the authorisation to lower the volume of the music, where required. A log book must be kept regarding these checks and be made available to the local authority inspection, if requested. Log book should contain the times the check was carried out, who carried out and any actions taken.
- Noise limiter is to be installed within 6 weeks of the granting of the license. The noise limiter must be set to a level agreed by the local authority.
- Appropriate SIA staff supervisor must be in attendance for live performances including DJ music. They should also be in charge of keeping the noise from your patrons located within the designated smoking area to a minimum.
- Signs must be placed up at entrances and exits to remind your patrons to respect the neighbours and leave the site quietly.
- Similar signs reminding your patrons to respect the neighbours and keep noise down to a minimum must be put up within the designated smoking area.
- CCTV operational during the hours of trading.
- No movement of bottles into outside bins after 23:00hrs
- External areas to be closed at 23.00hrs.
- No live or recorded music outside.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: ¹/₂ pint;

(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and

(iii) still wine in a glass: 125 ml; and

(b) customers are made aware of the availability of these measures.
