4. JOINT TRANSPORTATION BOARD

4.1 Purpose

The Board will consider capital and revenue funded works programmes; traffic regulation orders; street management proposals and provide advice on these matters to the relevant executive, as appropriate.

4.2 Terms of Reference:

The Joint Transportation Board will:

- a) Consider:
- i. Capital and revenue funded works programmes;
- ii. Traffic regulation orders;
- iii. Street management proposals; and will provide advice on these matters to the relevant executive, as appropriate;
- b) Be a forum for consultation between Kent County Council and the Council on policies, plans and strategies related to highways, road traffic and public transport;
- c) Review the progress and outturn of works and business performance indicators;
- d) Recommend and advise on the prioritisation of bids for future programmes of work;
- e) Receive reports on highways and transportation needs within the District.

4.3 Composition

4.3.1 Membership:

- **4.3.1(a)** All KCC members for divisions in the District Council's area and an equal number of members appointed by the District Council, and a representative of the parish and town councils within the District.
- **4.3.1(b)** District Council members are appointed by the Leader of the Council.

4.4 Chairman

In alternate years, a member of KCC (who is a member of the JTB) will chair the JTB and a District Council member (who is a member of the JTB) will be Vice-Chairman of the JTB, and then a member of the District Council will chair the JTB and a KCC member will be Vice-Chairman of the JTB and so on, following on the arrangements which existed in the year before the new agreement came into force. The respective councils will appoint the Chairman and Vice-Chairman, as they may determine, within their constitutional arrangements. The Chairman and Vice-Chairman of the JTB will take office at the first meeting of the JTB, following the annual meetings of both councils each year.

Declarations of Interest

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

12. **Declarations of interest**

Although none of the parking proposals would impact on him, Cllr Rory Love made a voluntary announcement of other interests in respect of the proposal to introduce parking restrictions on Harbour Way, outside Kingsbridge Court.

13. Minutes

The minutes of the meeting held on 23 November 2020 were submitted and approved. The Chairman's signature would be added to these minutes as approved.

14. Proposed Parking Restrictions 2021

Mr Paul Thompson introduced this report which he said, outlined the areas where restrictions would help to improve traffic flow, safety margins and resolve parking problems.

Members asked a number of specific questions on the proposed schemes detailed in the report as follows:

Harbour Way, Folkestone – In answer to a question from Cllr Love, Mr Thompson said none of the residents of Kingsbridge Court had indicated they would be unhappy to see part of the grass verge removed. Mr Thompson also said there had been no requests to pave this area, and he doubted if there would be any funding available to extend the highway in order to allow parking.

HGV Overnight and Weekend Ban – Slip Road adjacent to A20 Newingreen – In answer to a question from Cllr Whybrow as to who was responsible for enforcing bans on overnight parking, Mr Bowen and Mr Thompson said any concerns residents had on this should be referred to KCC direct. Cllr Mrs Carey said, whilst KCC was unable to provide an on- demand service, she knew it was very aware of problems of this kind, and in areas where there were hotspots

The Joint Transportation Board asked officers to provide an update on this matter to its next meeting.

RESOLVED

- (i) That Traffic Regulation Orders be made or amended in the summer of 2021 for all the proposals set out in Report JTB/20/06. And it be noted that before a TRO is made, the regulations require statutory consultations with all affected persons.
- (ii) Officers would provide an update to the next meeting of the Joint Transportation Board on the enforcement within Folkestone and Hythe of the KCC HGV ban TRO.

15. Highway Works Programme 2020/21

dealt with as many cases as possible.

This report updated Members of the Joint Transportation Board on the schemes approved for construction and programmed for delivery in 2020/21. Members noted that as Kent County Council had agreed a substantial increase in the budget for planned highway works over the next three years, work was still in progress to identify and design schemes for inclusion in the full Year One to Two (2020/21 and 2020/21) and Year Three to Five (2021/22 to 2023/24) programmes. Because of this, it had been decided to publish an interim programme, and to publish the full programmes later this year. For some assets, the interim programme covered approximately the first six months of 2020/21, whilst for others it included most of the works planned for the whole year. The programme was subject to regular review and may change for a number of reasons including budget allocation, contract rate changes, and to reflect KCC's changing priorities. The programme and extent of individual sites within the programme may also be revised following engineering assessment during the design phase.

Members asked a number of specific questions on the schemes detailed in the report as follows:

Appendix B – Robin Hood Lane, Lydd – Gully and kerbing work.

In answer to a question from Cllr Hills, Mr Bowen said he had noted what Cllr Hills had said about problems still occurring during periods of bad weather and would liaise with him as appropriate to discuss possible remedial action.

Appendix D – Risborough Lane Junction with Church Road – Installation of a Zebra Crossing Point.

In answer to request from Cllr Love for more information on this scheme, Mr Bowen would contact him direct.

Appendix D – Dover Hill and New Dover Road.

Cllr Pascoe said, whilst welcoming the road safety improvements being undertaken as described in the report, he still had concerns about traffic speeding on Dover Hill and asked whether any further measures could be taken to address those concerns. Mr Bowen said the situation would be monitored.

Appendix E – Cheriton High Street – Installation of Traffic Lights.

In answer to a point raised by Cllr Gane, Mr Bowen said that there would be a Safety Audit undertaken in respect of the new traffic lights at the Tesco/Horn Street/Cheriton Approach junctions. Any changes arising from that Audit would ne reported to Members.

In answer to a question from Cllr Love on the same scheme, Mr Bowen said he would look at the suggestion of having a light controlled pedestrian priority as part of the Safety Audit.

Appendix E – Ashely Avenue – Access to Recycling Facility

In answer to questions from Cllr Gane, Cllr Pascoe, Cllr Love and Cllr Monk, Mr Bowen said the latest planning application had been approved by KCC in February 2021. Mr Bowen said he would investigate the concerns that had been raised by Members, particularly with regard to vehicles over 7.5 tons accessing the recycling facility via Ashley Avenue. He would report his findings back to Members of the Board as soon as possible.

Appendix E – A259 Martello Lakes (Nicholls Quarry)

Mr Bowen said he understood a proposal would be coming forward for a roundabout to be put in at this location.

Appendix H – Cheriton High Street – Upgrade to Puffin Crossings

In answer to a question from Cllr Love, Mr Bowen said he would look into his concerns regarding pedestrian safety and the need for a far side indicator and contact him direct.

Appendix H – School Road, Saltwood – 20 MPH Speed Limit.

In answer to a question from Cllr Love, Mr Bowen said he would investigate the need for 20 MPH repeater roundels and contact him direct.

Appendix G – Bridge Refurbishment – Old Romney

In answer to a request from Cllr Hills for more information, Mr Bowen said he would contact Cllr Hills on this direct.

Appendix H - Combined Member Grant - Dunes Road, Greatstone

Mr Bowen would contact Cllr Hills to give him an update on this scheme.

1. Introduction

This report provides an update and summarises schemes that have been programmed for delivery in 2021/22 and 2022/23.

Kent County Council has recently published a forward works programme for the next five years covering planned maintenance of our highway assets. It is in two parts: the first concerns the next two years (2021/22 - 2022/23), and most of the sites included have already been verified by our engineers. The second part relates to years three to five of our five-year programme (2023/24 - 2025/26) and is largely based on data from our asset management systems, so may be subject to more changes as the schemes are verified.

This programme is subject to regular review and may change for a number of reasons including budget allocation, contract rate changes, and to reflect our changing priorities. The programme and extent of individual sites within the programme may also be revised following engineering assessment during the design phase, and additional sites may be added or others advanced if their condition deteriorates rapidly so that we need to react in order to keep the highway in a safe and serviceable condition.
