Annex 1- Mandatory Conditions

Mandatory conditions where licence authorises supply of alcohol

(1) Where a premises licence authorises the supply of alcohol, the licence must include the following conditions.

(2) The first condition is that no supply of alcohol may be made under the premises licence-

(a) at a time when there is no designated premises supervisor in respect of the premises licence, or

(b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

(3) The second condition is that every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Annex 2 - Conditions Consistent with the Operating Schedule

General - to meet all objectives.

Intoxicating liquor may only be sold or supplied to members of the club of two day standing and their bonafide guests.

The list of names and addresses of any club members must be kept on the premises and shall be produced on demand to a police constable in uniform.

The names and addresses of the guest introduced to the club shall be entered into a guest book by a club member concerned and the member shall sign the entry. This book must be kept on the premises and produced on demand to a Police Constable in uniform.

Protection of children from harm Operating Schedule.

Alcohol will not be served to children.
