FHDC manage On-Street Parking on behalf of KCC

Protocol Document sets out responsibilities

- District Activities
 - Parking related Traffic Regulation Orders (TROs)
 - Controlled Parking Zones
 - Disabled persons' parking bays
 - Limited waiting bays
 - Loading bays
 - Other specified bays e.g. taxi etc.
 - Maintenance of lines and signs
 - Access Highlight Markings
 - Enforcement

- County Activities
 - ➤ Safety related TROs
 - ➤ Moving Traffic
 - > Bus lane enforcement



CONTROLLED PARKING ZONES (CPZs) APPLICATION

Application process agreed by F&H Cabinet in 2014

Points based system to assess applications

- Location
- Points of interest
- Cause and times of congestion
- Extent of the problem
- Strength of initial support

An average of around 12-15 applications each year

Minimum of two schemes prioritised each year

Ward Members notified

CPZ IMPLEMENTATION

Informal consultations with residents within the proposed zone

Analyses of responses

Report to cabinet member who will decide on whether to progress scheme

Formal consultation on proposed traffic regulation order (TRO)

Consider objections and report to cabinet member who will decide on whether to implement scheme

Decision to implement-TRO sent to KCC to be sealed, lines and signs installation, issuing of permits

CPZ review usually after 12 months

Implemented 16 CPZS of varying sizes so far

ZONE C2 – The Stade (Introduction of loading restrictions and loading bays)	Decision to implement
ZONE T1 (Proposed extension to include Marine St. Walk, Hythe)	Consultations to start this autumn

TRAFFIC REGULATION ORDERS (TROs)

District responsibility to make some TROs- CPZs, limited waiting bays, Disabled bays, loading bays, footway parking, taxi bays etc

TROs governed by procedure regulations –

- Formal Consultations- ward members, stakeholders, residents & businesses
- Advertise Proposals
- Allow a minimum of 21 days for objections,
- Investigate/seek to resolve any objections
- Submit unresolved objections to decision-maker, who decides to implement, modify or abandon scheme
- Decision to implement agreed scheme- Submit TRO to KCC for sealing, commission signing & lining, issue permits for CPZs
