Details of claim (continued)

The Claimant is the Local Planning Authority as defined by section 1 of the Town and Country Planning Act 1990. The Defendants are the freehold owners of land at Canterbury Road, Selsted, Dover, Kent and Persons Unknown.

The Claimant has statutory functions in respect of breaches of planning control within its administrative area and the power to apply for injunctions restraining actual or apprehended breaches of planning control when it considers it necessary or expedient to do so.

Actual breaches of planning control have occurred on the land subject to this application. An existing order protecting the land was granted on 30 July 2020 and is to expire on 1 August 2022.

The land is under new ownership since the earlier order was granted. The Claimant now seeks an order against the new owners and persons unknown protecting the land for a further two years or until such time as planning permission is granted for its lawful development.
