 - Affordable Housing to be a minimum of 22%
 - Wheelchair housing noted as 10% of homes (aligned to elderly homes) subject to need.
 - Self-Build section commits to deliver 5% of market housing as self-build plots provided market demand exists with a shortfall in demand meaning that the plots would be delivered as conventional market housing.

 - Telecommunications section detail added regarding full fibre connections.

 - Specific details of the Fabric Energy Efficiency Standards to be met by domestic properties added.
