Dear Mr. Madden,

In response to your email of 10th May 2021, and having read your full report I do not feel that my objections have been addressed nor considered. therefore I wish for my objections to the Stopping Up of Princes Parade to remain in place.

The direct significant disadvantages or losses and inconvenience which will be suffered as a direct consequence of the stopping up of Princes Parade to the heavily populated areas of Twiss Road; Stade Street; St Leonards Rd; South Road; West Parade; Marine Parade; Fishermans Beach; Pitt Gardens; Twiss Ave; Field Walk; Turner Ave; Napier Gardens; Tower Gardens; Lynton Road; Windmill St; Albert Lane; Albert Gardens; Park Road; Victoria Road; Ormande Road; Albert Road; Cobden Road; Theresa Road; Parkfield Way; Range Road; Cinque Ports Ave; New Road; Hilda Road; The Avenue; Parkway; Corbay; Earlsfield Way; Imperial Gardens and Moncrieff Gardens, most of which are narrow roads lined by Victorian terrace houses with no off-street parking, has not been taken into consideration.

Since the introduction of Parking Meters on Princes Parade, visitors to Hythe have taken to parking in the above *locations*, making life very difficult and inconvenient for the residents and making it impossible (especially at weekends) to park within one mile of their homes and forcing them to block the road in order to unload shopping, elderly family etc. Similarly, for any delivery vehicles, especially supermarket delivery vans, who have no choice but to block the roads in order to make a delivery. With the Stopping Up of Princes Parade the situation will increase significantly. The basic fact that all Emergency vehicles will be forced to negotiate the narrow, heavily parked Twiss Road, Stade Street or St Leonards Road in order to attend any of the properties in the above *locations*, **thus delaying attendance and risking lives, has not been considered or address at all.** 

A speedy exit route for Fire Engines leaving the Fire Station located in Parkfield Way to attend 999 emergency calls **has not been addressed or considered**. Similarly, HGV's delivering to businesses and the Industrial Estate in the above *locations* **has not been addressed or considered**.

It is for the above reasons that I wish for my objections to the Stopping Up Order to Remain In Place

## Why we're contacting you

We're contacting you because you responded to the statutory consultation regarding the stopping up and diversion of the highway known as Princes Parade. This consultation ended on 7 June 2018. Since then, the development has been subject to a judicial review which was finally dismissed on 29 November 2019.
