# **Shepway Core Strategy Local Plan (& Policies Map) 2013**

## **Final Errata - Updated**

The following is a list of the factual corrections inserted to the final Core Strategy Local Plan & Policies Map.

The final changes feature in the printed documentation<sup>1</sup> circulated to the public. However there is one important exception, an error in the (Appendix 5) list: further Countryside policies have been deleted. This was identified in early 2014 so this error remains in printed documents. See the antepenultimate bullet point in the Core Strategy list below.

To confirm the Appendix 5 (Local Plan Review policies from 2006 that continue to apply) errors in the plan as presented for adoption, these policies supporting the Core Strategy include LR5, but exclude CO7 – CO10. (This is consistent with the deletion of policies made in the main body of the Core Strategy e.g. para 5.58).

The Core Strategy document on the council's website is fully corrected in line with all errors below.

Changes are applicable as follows to the documents attached to the Shepway Council adoption report (18<sup>th</sup> September 2013). They are made under delegated authority as approved under resolution (5) on the agenda item.
