Morning.

I would like to OBJECT most strongly, to the stopping up (moving) of the Princes Parade road, for the following reasons.

We have lived in Seabrook for over 30 years and use Princes Parade on a daily basis, either jogging every morning or just for a walk. We therefore have, i think, a unique insight into the reality and hard facts, supporting the virtues of keeping the Princes Parade road as it is, something sadly lacking by a council that wilfully ignores public opinion and comments on facilities and subjects they neither use or know anything about!

First.

The council say it, "will improve access to the beach", how absurd. The road runs along the side of the beach, couldn't be any easier!! 100% accessible. Moving the road to the canal bank destroys access not improves it. Typical bonkers thinking from a council that waisted 10s of thousands of pounds, putting parking meters on the wrong side of Princes Parade, making the public cross, what is a busy road, to get a ticket and cross back again, brilliant idea!!

Third.

Splitting traffic, halves the congestion, makes sense.

Fourth.

The road is so enjoyable, all year round as a compliment to the the beautiful area that is Princes Parade.

Moving it to the canal bank would not only deprive everyone of the undoubted advantages of where it is now but destroy the setting of the Royal Military Canal, as a tranquil, peaceful, thoughly lovely place to enjoy, a fact lost on certain councillors who steadfastly refuse to, "have a walk" and see exactly what they intend to destroy.

So moving the road would have a DOUBLE detrimental effect, on what we have now and in the future.

Fifth.

Seventh.

Environmentally, it's a disaster. All sorts of pollutants heading into the canal, as council plans stand, from the road traffic, don't forget they'll be 150 more houses, with car movements to boot. Not to mention noise pollution on nearby swan nests, etc, now so close to the road. The wildlife will be traumatised at what our councillors think is a GOOD IDEA. The badgers might as well call it a day, corralled into a far smaller area to the west, against their will (the council can do anything) and now in very close proximity to the re-routed road, within feet actually. while, doesn't mean it's got to go!! It's worthy of it's place in our daily pursuit of happiness and it's only a wall, wow.

Ninth

So many parking spaces would be lost. This council thinks people will walk or cycle to the beech, denying the existence of cars, weird, soon to be mostly electric.

Often on a sunny weekend, the whole of Princes Parade is taken up by parked cars it's entire full length and an absolute joy to see everyone enjoying all sorts, paddle boarding, family day out, canoeing, bbqing, swimming, because they have easy parking and access. All that would go, instead, driving along a diverted road/street, through a housing estate, looking for, now, limited parking and then having to carry all your kit to the beech. Easier if you can just pull up along side a.!! ③

Please please, don't divert Princes Parade.

It's such an asset the way it is, for all visitors and locals alike. It's served us well for over a hundred years and seen countless generations enjoy all of it's lovelyness! How wrong to take all that away, because a few narrow minded councillors want to move it, to create a housing estate.

We can do so much better than that.

Don't forget we live here and know of it's benefits first hand, especially also to the emergency sevices, so handy to avoid all sorts of congestion on the Seabrook road, have seen that on many occasions.
