

Sub area forecasts/ projections for Shepway DC

This file outlines the projected demographic growth for three sub-areas within Shepway DC between 2006 and 2026.

Forecasts/ projections have been produced for the district as a whole and for individual wards within the district. Following guidance from SHDC the ward figures have then been aggregated to reflect growth for the three sub-areas.

Option 8000 - A strategy-based forecast which looks at the how population of Shepway might change based on building an additional 8,000 dwellings in the district between 2006 and 2026.

Option 6000 - A strategy-based forecast which looks at the how population of Shepway might change based on building an additional 6,000 dwellings in the district between 2006 and 2026.

Zero Net Migration - a projection based on the assumption that there will be no net migration to Shepway. All of the growth seen in this projection is therefore indigenous growth.

Long Term Migration trend - a projection based on an average of net migration over the last 15 years (1991-2006). This equates to 620 net migrants per annum. This projections looks at Shepway's future demographic change if this level of net migration continued indefinitely into the future.

The forecasting model

The ward forecasts/ projections (and subsequent settlement forecasts/ projections) have been produced using a forecasting model produced in-house by KCC. The ward level model is less robust than the district-level model used and for this reason the ward and settlement forecasts/ projections should be used with caution. More detail regarding the ward level model is provided on the 'Health warning - Ward forecasts' worksheet.

At ward level, forecasts are only available for the following; total population, population by 5-year age group, total dwellings and total households. More detail is available at district level. This file contains results for the total population, dwellings and households.

Summary of findings

For two of the three sub-areas (the Urban Area and North Downs sub-areas) the ZNM projection shows a lower level of growth than each of the housing-led options. This provides an indication that the future housing provision planned within each of the sub-areas is above the indigenous population's needs. However, for the Romney Marsh sub-area the ZNM projection shows a higher level of growth than each of the housing-led growth options. This suggests that the current housing provision will not meet the indigenous population's needs of the Romney Marsh area.

KCC's ward level population forecasts – health warnings

- Whereas the district level forecasts are produced using a sophisticated, robust and widely-available forecasting model (Chelmer), the ward level forecasts are produced using a model developed in-house.
- The ward model is less sophisticated. It works on the basic principle:
 - Apply 2001 Census vacancy and sharing rates to the estimated number of dwellings to obtain an estimate of the number of households. Multiply the number of households by the average household and add the institutional population to obtain an estimate of the resident population. To ensure the ward forecasts are consistent with our district level forecasts we control the ward dwelling, household and resident population counts to the district total.
- The ward model does not take into account:
 - changing household formation rates directly, like the district level forecasts do. We attempt to model the impact of changing household formation on average household size by applying the district rate of change in average household size to the average household size for each individual ward which is initially based on the 2001 Census average. For this reason, average household size is an input in the ward level forecasts but an output in the district level forecasts.
 - migration. It is not possible to monitor this at ward level in the detail required but by controlling to the district level forecasts we are indirectly taking migration into account.
 - changes in ward level births and deaths. Again, by controlling to the district level forecasts we are indirectly taking these into account but it will not be specific to the individual ward.
- We distribute the population growth within the district based on what we know of where the new housing developments will be taking place. Shepway DC have provided the future housing provision for the three sub-district areas. The housing provision is outlined on the housing provision sheet.
- At ward level, forecasts are only available for the following; total population, population by 5-year age group, total dwellings and total households. More detail is available at district level.











Shepway Labour Supply Options

The Labour Supply Options have been produced, based on the following population assumptions:

- Option 1 Zero-net migration
- Option 2 Long-term trend migration
- Option 3 Option 6,000 dwellings
- Option 4 Option 8,000 dwellings

Methodology:

- 1 The population assumptions for each Option are disaggregated by gender and age band.
- 2 Activity rates are calculated for each gender/age band, based on local 2001 Census data, which are then rolled forward using national growth rates as set out in the publication "Labour Force Projections 2006-2020" published by the Office for National Statistics. Activity rates are then held constant from 2020 to 2026.
- 3 The Resident Labour Supply is derived by multiplying each gender/age cohort by the relevant activity rate.
- 4 A 2001 Census workplace ratio figure is then used to convert the resident labour supply to a workplace-based labour supply. This gives an approximation to the likely number of people looking for work in Maidstone as it allows for a proportion of the working population to commute elsewhere for work. Overall, Shepway was a net exporter of labour in 2001, as is shown in the data. Shepway exported a higher level of male workers than it exported female workers.
- 5 The workplace ratio has a significant impact in terms of estimating the number of workers likely to be working in Shepway. The overall figures show that Shepway was a net exporter of labour in 2001. More recent work undertaken by Research & Intelligence, that has attempted to update the 2001 journey to work matrix data, has confirmed that Shepway is still a net exporter of labour and that the ratio of resident to workplace labour has changed very little since 2001. However, the estimates from this work are not detailed enough (i.e. disaggregated by sex and age) to allow an accurate adjustment to be made in the labour supply forecasts. For this reason the 2001 Census ratio is applied throughout to time-series.
- 6 Some sensitivity testing has been carried out, to examine the impact of continued growth in activity rates within the older age bands, beyond 2020 (the limit of the national activity rate projections). It is likely that the governments plans to phase in the standardisation of retirement ages for both men and women to 65 and then to consider the option of even later retirement (at 68), would have an impact that was not considered at the time the national projections were produced.
- 7 Alternative projections for the two age bands 60-64 and 65-69 have been produced on the basis that the growth in the last 6 years of the forecasts (between 2020 and 2026) will continue to grow at half the rate that took place during the previous 6 years (2014 to 2020). This method is considered preferable to just projecting the recent trend forward at the same rate, as there is likely to be a finite limit to the extent to which the older populations could remain economically active, so the activity rates should not be allowed to continue to increase at the same rate indefinitely. See SumaryTable2.
- 8 Finally, an assessment of the dependency ratio has been made. This is the ratio between those who are economically active to those who are economically inactive. The ratio's primary use (usually at a national level) is to examine the relationship between those who are most likely to make demands on public spending (those in full-time education, those who are retired and the long-term sick) compared to those who are likely to be paying for public services, through taxation.

There are some marginal differences in the dependency ratio between the forecast options, however, the broad picture is in line with the county ratio in that the dependency ratio increases from 1.1 in 2006 to about 1.4 by 2026.





Methodology

- 1 Each forecast option plus the two trend forecasts are set out in separate worksheets.
- 2 The population data by age band is set out.
- 3 2001 Activity rates have been calculated for the sub area.
- 4 The 2001 Census activity rates have then been projected forward using growth rates from the national labour force projections.
- 5 Economically active population (labour supply) is then calculated by multiplying the population by the projected activity rates.
- 6 Finally, the economically active population for the sub-areas is controlled to the District level projections. This stage is necessary, due to the less robust nature of the ward level forecasts and the broader approach to calculating activity rate growth (i.e. the use of total activity rates and total activity rate growth, rather than the application of gender-specific rates).
- 7 A summary table brings the top-line figures together, for each of the options. These figures are then charted for each option.






Zero-net Migration Trend
