2023 satisfaction survey action plan

More than 680 residents took part in our tenant and leaseholder satisfaction survey, which was sent to all of our tenants between May and August 2023. Thank you all for feeding back to us about the housing service.

The survey was based around the Regulator of Social Housing's **Tenant Satisfaction Measures**, which all social landlords are required to collect data for and report to the Regulator.

We published the summary results of the survey in our January newsletter and have since created an action plan based on the feedback we received.

Your voice our action

We have looked at all of the survey results, together with the Strategic Tenant Advisory Panel, to create an action plan of what is being done this year to make our housing service the best it can be. The action plan includes:

💢 Repairs

- Reviewing all the comments received, to highlight whether there are any specific issues in certain areas and/or for certain types of repair
- Exploring the best ways of raising tenant awareness about the housing service's health and safety work

Complaints

- Reminding residents what is, and isn't, classed as a complaint, and of the housing service's target time for responding to complaints
- Exploring how to improve how the housing service can learn from complaints
- Conducting a Tenant Scrutiny Panel review of complaints and/or for certain types of repair

Neighbourhood management

- Advertising cleaning contract standards once the new contract begins
- Reviewing how best to promote work the housing service does to improve neighbourhoods

😾 Anti-social behaviour

- Reminding residents what is, and isn't, classed as anti-social behaviour, and what the housing service is, and isn't, able to do
- Conducting a Tenant Scrutiny Panel review of anti-social behaviour

- Complete the survey either online at lake-research.com/fhtenant or by filling in the paper survey and returning it in the freepost envelope provided. It should only take you around 10 minutes. Your views are really important to us as they help shape how we run the housing service. The survey closing date is 12 July.
- We'll use the responses to calculate data for annual tenant satisfaction measures, which we are required to report to the Regulator of Social Housing. We will publish the data, and what we plan to do as a result, in a future issue of the tenant bulletin.





Join the housing team on your local neighbourhood inspection

Our neighbourhood inspections take place during spring and summer and they are an opportunity for tenants to meet with staff and contractor representatives to share concerns and help us identify any problems in their area.

As part of the inspection, you'll be involved in checking the condition of your neighbourhood, buildings and communal areas. You can advise on issues such as caretaking, rubbish and fly-tipping, as well as report any repairs needed.

PRENT REMINDER: If you're a tenant in our district and receiving Universal Credit, here's some important information about your rent. This year there are 53 Mondays. If you receive Universal Credit, the Department for Work and Pensions will not cover the extra week of rent.

What this means if you're a tenant on Universal Credit

you'll have a monthly shortfall to pay towards your rent in addition what you receive via Universal Credit.

you'll need to make up the shortfall yourself from your earnings, or personal element of Universal Credit

If you're unsure how to work this out, and you're struggling to pay your rent, call us on 01303 853300

Make things right

We are committed to always providing a high level of service and we want to know if you are dissatisfied with any service you have received. If you have an issue with your home there are steps you can take to make things right.

Step 1 - Report it to us

You can email any issues directly to us on housing.service@folkestone-hythe.gov.uk

Step 2 - Make an official complaint

If you've reported an issue and it hasn't been sorted or you're not happy you can complain using our complaints process. You can find out how to do that on our website: folkestonehythe.gov.uk/council-transparency/ complaints-compliments-feedback

Step 3 – Escalate to the Housing Ombudsman

If you're not happy with our final response to a complaint, you can escalate it to the Housing Ombudsman. They are free to use, impartial and will investigate fairly. Investigations take six months on average but can be faster or slower, depending on the case. The Ombudsman will check the facts and be thorough.
