

**THE KENT COUNTY COUNCIL (VARIOUS ROADS, FOLKESTONE AND HYPHE)
(WAITING RESTRICTIONS AND STREET PARKING PLACES)
(CONSOLIDATION) ORDER 2025 (AMENDMENT 17) ORDER 2026**

ROAD TRAFFIC REGULATION ACT 1984

The Kent County Council, acting as the Local Traffic Authority and in exercise of its powers and under Sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 44, 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984 ('the Act') and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order shall come into operation on XXXXX and may be cited as "The Kent County Council (Various Roads, Folkestone & Hythe) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2025 (Amendment No.17) Order 2026" ('this Order')
2. The Interpretation Act 1978 shall apply to this Order as it applies for the interpretation of an Act of Parliament.
3. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, 'The Kent County Council (Various Roads, Folkestone & Hythe) (Waiting Restrictions and Street Parking Places) (Consolidation) Order 2025' ('the Order of 2025') shall have effect as though:
