I object to the stopping up of the road at Princes Parade.

The road is a valuable asset for local residents and tourism and allows access to the beach area for those travelling by car. The elderly, disabled and families as well as sports enthusiasts. Allowing equipment for a day at the beach to be transported easily.

The benefits to visitors are immense for wellbeing of a drive beside the sea or a quick lunch break and de stress.

The stopping up of this road would create access to the beach by foot only. This would severely restrict access to the beach and sea to many community groups.

This road is a valuable alternative to Seabrook Road and assists with traffic management. To lose this road would put a huge strain on neighbouring roads and create traffic congestion. The yearly roadworks on Seabrook Road entails Princes Parade being used as an alternative route. The 2 roads are both very busy routes with additional increased traffic at peak times and holidays.
