29. **Declarations of interest**

There were no declarations of interest.

30. Minutes

The minutes of the meeting held on 4 July 2016 were submitted, approved and signed by the Chairman subject to the following amendments:

- That the list of those present be amended to correctly record Councillor Malcolm Dearden as Chairman.
- Minute 27 bullet point one "Toad" be replaced by "Road"
- Minute 27 bullet point three "Lympne" be replaced by "Lydd".

Members noted the following updates from the minutes of the last meeting as follows:

 That the cost of pond clearance and treatment of Japanese Knotweed in Canterbury Road, Hawkinge had been £68,101.49. All plants had been cut down and contaminated soil removed. In addition the roots had been buried, a root barrier put in place and a concrete cap installed. A final inspection by Kent County Council would take place that month. Officers were asked to confirm whether any funding had been received from the Environment Agency toward the work described.

- That the concerns raised by the JTB regarding Scanlon's Bridge had been raised at the Safety Audit currently being undertaken and a full report would be considered by the JTB at its meeting scheduled for December.
- That the suggestion by Mr Bryer, speaker at the last meeting of the JTB, to extend the 30mph speed limit further up Lypmne Hill as part of the Traffic Calming Scheme described in minute 28 had been investigated and with the support of the Police would be duly extended as described.

31. Highways Works programme

Report JTB/16/03 updates members on the identified schemes.

Members noted the following:

- Station Road, New Romney entry Mrs Carole Waters informed that she
 had received a complaint from a local resident who had questioned the
 value of the scheme and also said that it had caused drainage issues at
 his property. The complainant also reported that the white lines in the
 middle of the road were not properly central and that the cat's eyes had
 not been replaced.
 - Officers agreed to pass on the concerns raised to the relevant surface engineer who would report back to Mrs Waters following an inspection.
- West Street, New Romney entry officers confirmed that the renewal and upgrade to existing drainage system had been completed and no complaints had been received. However, it was acknowledged that the weather had been dry and that checks would be made to ensure that all was in order. Mrs Waters would be informed of the outcome of any such checks.
- B2068 Stone Street entry Frank Hobbs informed members that there
 was an adverse camber toward the top of Hampton Hill at the Farthing
 Junction that he believed to be dangerous. Officers asked that this be
 reported via Kent County Council's on line reporting tool.
- A2033 Tontine Street to Sandgate Road, Folkestone Central entry –
 Members were informed that following proposals regarding street signs in the area that no amendments to the original plans would now be made.
- Horn Street/Church Road, Cheriton entry It was reported that St Martin's C of E Primary School continued to experience traffic problems at pick up and drop off times. Councillor Peter Gane believed that traffic calming measures had been agreed some time ago but as yet had not been implemented. He also informed that he believed the school would have made representations regarding this issue during the consultation period.

Officers informed members that only those measures approved in the original designs would be implemented and that no amendments or additions would now be agreed, Pauline Rockett agreed to check and report back to Mr Gane.

Members raised concerns in respect of both Church Lane and the Horn Street Bridge currently difficult for motorists to utilise. Members were informed that network Rail had been contacted about replacing the bridge but had quoted a cost for the works that was prohibitive.

 Combined Member Fund Scheme at Smallpox Hill, Folkestone – It was confirmed that a drop down bollard had now been installed and two keys provided to the council.

Concerns were raised with regards to some vehicles still accessing the area by driving on to the grass verge and it was agreed that officers investigate and take any necessary actions.

32. KCC Highways scheme Schools Cluster to Folkestone Harbour cycle route improvements update

Report JTB/16/04 updates members on the KCC Highways Scheme Schools Cluster to Folkestone Harbour Cycle Route, improvements update.

The Chairman introduced the report for members and explained that it related to an LTP bid first made in 2011 to improve cycle route provision between the Morehall School Cluster and Folkestone Harbour.

Members paid particular attention to the following:

- The news that the scheme was progressing was welcomed by members, showing the council's commitment to cycling, working alongside local groups, such as, Shepway Cycle forum has also helped with the progression.
- It was reported that the scheme title had been chosen by KCC officers and that it may not extend all the way to Morehall but was considered to be the best fit description by officers there.
- Officers agreed to clarify certain destinations described on the routes and would look at the installation of cycle racks, at key points, along the routes.
- Members referred to the Council's cycling strategy and the benefit that it created by allowing funding to be taken for strategic match projects where it became available.

Resolved:

To board noted report JTB/16/04 and benefits of the related cycling strategy and progress of the scheme.

33. Kent County Council Local Transport Plan 4: Delivering Growth without Gridlock (2016 2031) (Consultation Draft)

Report JTB/16/05 Kent County Council (KCC) has a statutory duty to have a Local Transport Plan (LTP). The current LTP3 (2011-16) needs to be replaced. This report introduces the draft LTP4 (2016-31).

Members were informed that the LTP4 was currently undergoing a statutory 12 week public consultation which would end on 30 October and to which key stakeholders were encouraged to respond, including the JTB boards across the county. Members were advised that they could respond individually as well as a collective.

Members were encouraged to consider the draft carefully and influence the document at its earliest stages. With this in mind Councillor Love asked tht the document seeks to ensure that any additional or replacement signage used in the county was consistent with in car sat-nav devices, to include the road name and number wherever possible.

Summary: This report outlines the arrangements that have been made between Kent County Council and Shepway District Council to provide a local winter service in the event of an operational snow alert in the borough/district

1. Introduction

- 1 (1) Kent County Council Highways, Transportation & Waste (KCC HTW) takes its winter service responsibilities very seriously and is proactive as well as reactive to winter weather conditions. Winter service costs KCC in the region of £3.2m every winter and needs careful management to achieve safety for the travelling public and to be efficient. The Highways Operations teams in HTW work to ensure that the winter service standards and decisions made are consistent across the whole county.
- 1(2) HTW prepares an annual Winter Service policy and plan which are used to determine actions that will be taken to manage its winter service operations. The policy was presented to the Environment and Transport Cabinet Committee on 9th September 2016 and subsequently approved by the Cabinet Member.

2. District based winter service plans

- 2(1) The Local Winter Service Plan for the Shepway District is a working document which will evolve and be revised as necessary throughout the year. This document complements the KCC Winter Service Policy and Plan 2016/17; the Policy is available on the KCC website.
- 2(2) Following successful work in previous years with district councils, arrangements have again been put in place this year whereby labour from

district councils can be used during snow days. Additionally HTW will supply a quantity of a salt/sand mixture to district councils to use on the highway network. The details are contained in the plan which enhances the work that HTW will continue to do in providing a countywide winter service. The local plan comes into effect when a snow emergency is declared that affects the district of Shepway.

3. Pavement clearance

3 (3) Areas for clearing pavements have been identified in the local plan. These are the areas where local knowledge has indicated that people are concerned and would most like to be kept clear when there is snow and ice.

4. Farmers

4(1) The work that our contracted farmers have done in recent years is greatly appreciated and has made a big difference in keeping rural areas clear on snow days. Again this year farmers will have predetermined local routes and will use their own tractor and KCC ploughs for clearing snow. The ploughs supplied are serviced by KCC each year. Each farmer will have plans detailing the roads that that they are responsible for ploughing. When snow reaches a depth of 50mm on roads in their areas the farmers will commence ploughing notifying KCC as agreed in their contract. A list of farmers and their contact details can be found in the local plan, (although some personal information will not be available via this report or the website due to Data Protection legislation).

5. Conclusion

Winter Service Handbook 2016/17 Shepway District



1. KHS policy statement and plan

This handbook supplements Kent County Council Highways and Transportation's Winter Service Policy Statement which was endorsed and adopted by Kent County Council's (KCC) Environment, Highways and Waste Policy Overview and Scrutiny Committee (EHW POSC). 2. Winter service procedure

During normal working hours the District Manager will deal with all winter service matters, including managing local action in snow/ice emergencies. The Duty Officer (DO) will assume control out of hours. District Manager (DM) will also ensure that adequate support is provided to DO out of hours in emergency situations and that a suitable handover briefing takes place at the start and end of the normal working day.

- 2.1 The Duty Officer will commence duty at 17.00 hours on Friday until 09.00 the following Friday and will be responsible for all the actions below. The DO may be required to become involved before 17:00 hrs to enable proper hand over of information. This will be dependant on the severity of the conditions. Assistance will be given but the ultimate responsibility will be with the DO.
- 2.2 Immediately after 1400 hours daily the weather forecast/information will be available on email/telephone on 03000 413111. (Update forecasts may be available at 21.30 hours each day, or when issued.)
- 2.3 **Instructing and recording actions** Any initial standard actions will be passed to Amey by the WDO. For normal in hours (09:00-17:00) The District team will record add hoc actions taken on the Winter Service action sheet. This will instruct Enterprise of the action that is needed. Provide as much detail as possible on the form. This is then sent by email to Amey advance of the work.

Out of hours (17:00 -09:00) and in the event that additional actions are needed also use the winter Service action Sheet, recording as much information as possible and pass this information by phone to the Amey Duty Supervisor. If, in the opinion of the duty officer, or on a site check, different action is taken to that recommended by the Winter Duty Officer (WDO), please inform the WDO. Amey will be informed directly of the main action. Duty Officer will decide and instruct on any other action needed.

The winter service action sheet should also be copied by email to the relevant Priority Response Officer, District Manager and Highway Manager. The PRO officer will

- ensure that a WAMS order is raised as soon as practicable. The PRO will save the form in the designated folder on the KHS IT system.
- 2.4 At weekends/bank holidays the winter forecast/action will be sent out at 14.00 hours or soon thereafter. In the event that a forecast is not received the DO will phone the KCC forecast on 03000 413111 to receive forecast and instructions.
- 2.5 If there are any changes, i.e. rain, contact the Amey Winter Duty Supervisor as soon as possible to cancel/ amend the instruction and inform the WDO
- 2.5 A snow/ice emergency can only be declared by a Highway Manager (HM). In the event of a snow/ice emergency being declared by the CDM, strategic action should considered, i.e. opening an Emergency Room and calling in other staff etc.
- 2.6 In a declared snow emergency the priorities are primary routes, secondary routes, recorded snow clearance priorities and finally anything reported by the public etc. All public reports are to be logged on the CSM system.

Farmer Snow Plough Agreements.

Farmers local to the area are under contract to plough snow on the more rural routes when necessary. Each farmer will have details of the roads to be ploughed. The farmer uses his own tractor, often with a KCC plough, which is serviced every year and maintained by KCC. When snow reaches a depth of 50mm on roads in their areas the farmers will commence ploughing. Before this occurs the farmer should phone the Contact Centre of the intention to start ploughing. This information will be relayed to the relevant area office. Otherwise KCC Highways staff will contact the farmer directly and instruct action. Farmers are paid by the hour when actually ploughing. The current contractual arrangements with farmers extend to (and include) the winter of 2014/15. The routes that are covered by the farmers are available on request.

5. Hand clearance and salting of key pedestrian areas and routes.

A note and maps indicating priority pedestrian areas and routes, including bridges and underpasses, for hand clearance and salting, either using Shepway District Council contractors and supervisors during snow emergencies or Amey operatives is available on line.

6. Snow clearance priorities, with details by town/area in priority order

Pedestrian areas, emergency service locations, A&E hospitals, hospitals, Schools (open), Schools (closed), Care Homes and Cemeteries. Full details can be found on line. The inclusion of these sites does not guarantee action will be taken at the locations as primary and secondary routes will always be actioned first.

7. Plans of primary and secondary routes

Maps showing the primary and secondary salting routes are able to be accessed on our website at the following address http://www.kent.gov.uk/SaltingRoutes/Map.aspx

7. Most bus routes will be covered by these routes but not all.

8. Salt bin locations

These will be periodically checked and restocked. The Winter Service Policy Statement and Plan sets out the procedures for deploying additional salt bins. During the Winter period, no additional salt bins will be deployed (unless funded through the Members'

Highways Fund). Any other requests/locations will be considered during the following Summer.

10. Salt bags

We are offering parish councils the opportunity to have a salt bag delivered again for the winter 2016/17. We will provide one salt bag per parish and this will be a one tonne bag of salt/sand mix. The salt bags will be placed at the start of the winter season for use in the local area, throughout the winter. However, due to the mild winters we have had, there should not be a need for new salt bags.
