Declarations of Interest

Disclosable Pecuniary Interest (DPI)

Where a Member has a new or registered DPI in a matter under consideration they must disclose that they have an interest and, unless the Monitoring Officer has agreed in advance that the DPI is a 'Sensitive Interest', explain the nature of that interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a DPI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation permitting them to do so. If during the consideration of any item a Member becomes aware that they have a DPI in the matter they should declare the interest immediately and, subject to any dispensations, withdraw from the meeting.

Other Significant Interest (OSI)

Where a Member is declaring an OSI they must also disclose the interest and explain the nature of the interest at the meeting. The Member must withdraw from the meeting at the commencement of the consideration of any matter in which they have declared a OSI and must not participate in any discussion of, or vote taken on, the matter unless they have been granted a dispensation to do so or the meeting is one at which members of the public are permitted to speak for the purpose of making representations, answering questions or giving evidence relating to the matter. In the latter case, the Member may only participate on the same basis as a member of the public and cannot participate in any discussion of, or vote taken on, the matter and must withdraw from the meeting in accordance with the Council's procedure rules.

Voluntary Announcement of Other Interests (VAOI)

Where a Member does not have either a DPI or OSI but is of the opinion that for transparency reasons alone s/he should make an announcement in respect of a matter under consideration, they can make a VAOI. A Member declaring a VAOI may still remain at the meeting and vote on the matter under consideration.

Note to the Code:

Situations in which a Member may wish to make a VAOI include membership of outside bodies that have made representations on agenda items; where a Member knows a person involved, but does not have a close association with that person; or where an item would affect the well-being of a Member, relative, close associate, employer, etc. but not his/her financial position. It should be emphasised that an effect on the financial position of a Member, relative, close associate, employer, etc OR an application made by a Member, relative, close associate, employer, etc would both probably constitute either an OSI or in some cases a DPI.

1. Appointment of Chairman

The District Council Members of the Board appointed Councillor David Godfrey as Chairman of the Folkestone & Hythe Joint Transportation Board for 2020-21.

2. Appointment of Vice-Chairman

The Board noted that Kent County Council had appointed Mr Tony Hills as Vice-Chairman of the Folkestone & Hythe Joint Transportation Board for 2020-21.

3. **Declarations of interest**

There were no declarations at the meeting.

4. Minutes

The minutes of the meeting held on 17 February 2020 were approved and signed by the Chairman subject to the following amendment:

Minute Number 13 refers to Cherry Garden Lane. This should be amended to read Cherry Garden Avenue.

With regard to Minute No 13, a Member queried why the TRO planned at Prospect Road in Hythe had not been added to the Highways work programme. The work programme should be a definitive list. The Interim Highway Manager (East Kent) confirmed that she would raise this with all other Highways Managers, and remind them to ensure that the work programme should show all works.

5. Proposed Parking Restrictions - September 2020

Report JTB/20/01 by the Folkestone and Hythe District Council Highway Engineer was presented to members. The report outlined the areas where restrictions would help to improve the traffic flow, safety margins and resolve parking problems.

Members commented on various issues, including the following:

- The yellow lines going down Coast Drive (3.4) needed to be extended. The Transportation Specialist had advised that it was the aim to get this in before Christmas.
- Motorhome Overnight ban (4) is there a sunset clause when introducing further traffic bans? Although sensible in the areas suggested, could it be reviewed after a year or 18 months? This had happened previously in Radnor Cliff Crescent, and a resident who owned his own motorhome, was prohibited from parking it near his home. Could a PSPO be used to cover this issue? The Transportation Lead Specialist advised that a PSPO could be used to enforce caravan parking, instead of a ban. It was agreed that a meeting be set up with the CSU to look at both options, and report back to the JTB.
- With regard to Tudor Road (3.1), the double lines would be welcomed, but could they be longer? The Transportation Specialist advised that this had not yet gone to consultation as yet, but there was scope for this to be tweaked. He would do a site visit and take measurements.
- With regard to Canterbury Road (3.4), it was a surprise the double yellow lines did not go nearer to the post office store. Parking on that stretch had been dire for a number of years. There was already an existing single yellow line, which was not respected. Could the officers confirm how often enforcement visits were carried out? The Transportation Specialist advised that a number of site visits had been undertaken, and that was what had been requested, but he was happy to discuss this further with the proposers. In terms of enforcement, this had been raised by KCC and the parish council. Enforcement was carried out, as it was anywhere else within rural areas.
- There was regularly a van parked on the junction with Crete Road West and Canterbury Road, which was being used as a motorhome, which someone was clearly living in. Was this permitted? The Transportation Specialist advised that he would discuss this issue with the CSU.

6. Highway Forward Works Programme - 2020/21

Report JTB/20/02 updated members on the identified schemes approved for construction.

The Interim Folkestone and Hythe District Manager (KCC) advised on an amendment, at Appendix E (developer funded schemes), with regard to Jointon Road, Folkestone, the commencement date should be November 2019, not 2020.

The following points were discussed:

- Appendix A Risborough Way and Risborough Lane resurfacing. Could this
 work be done at a different time to the work at Tesco, to avoid major
 congestion?
- Appendix D Shorncliffe Road junction with Audley Road, Folkestone. Was this part of the original scheme? Could the JTB see a plan showing the proposals?
- Appendix E Cheriton High Street/Cheriton Approach. Was this on schedule, and was Phase II the final phase? The Interim Highway Manager for East Kent stated that she would seek clarity on this and report back to the JTB.
- Appendix A Cherry Garden Avenue the paving was undulating here, and dangerous. It should never have been signed off.
- Appendix B Dungeness Road the vegetation was growing in the dips, preventing the water from draining away. This was very dangerous and should be looked at urgently.
- Appendix A A20 Ashford Road, this extended to Sellindge, Lympne, Stanford and Saltwood, rather than Hythe.
- Appendix A Staple Lane Postling The Micro Surfacing done was working really well. The hot weather had been a concern but had made no difference.
- Appendix I both schemes. Thanks to Damien Cock for his help with these two schemes, which were welcomed by residents.
- Appendix F Had requested for pathway in Park Farm Road to be investigated, opposite the fire station. The path was being disturbed by tree roots. Could this be looked at urgently?
- Appendix C request addition replacement of street light at the bend at Coast Drive (outside Demetrios restaurant), which had disappeared.
- Appendix F request addition Martello Lakes, cycle path lots of grass, weed and undergrowth growing in gutter which needed to be looked at.

The Interim Folkestone and Hythe Manager advised that he would report these issues back to KCC.

The JTB indicated their thanks to the Highways staff, and district Council Officers for their efforts during particularly trying circumstances.

SUBJECT: PUBLIC SPACES PROTECTION ORDER (PSPO)

SUMMARY: Overview of the Public Spaces Protection Order – Measure 7

At the last JTB held on 21 September 2020 members requested information around the benefits of a PSPO over a Traffic Regulation Order (TRO). (See Appendix 1 PSPOs vs TROs).

This briefing note provides members with information of the PSPO in regards to what can be enforced and the areas.

1. The Public Spaces Protection Order

During 2018 -19 Folkestone & Hythe District Council undertook an extensive public consultation to renew its existing PSPO. Following public consultation the new PSPO was implemented in June 2019 and covers seven measures that address antisocial behaviour being experienced, covering bespoke areas of the District.

Under this Order, Kent Police and Folkestone & Hythe District Council are able to move on anyone who continues to act in an anti-social manner having been asked not to do so within the criteria of the Order.

Under the PSPO measure 7 is - Unauthorised camping

- No person shall position any vehicle, caravan, tent or other temporary structures that are designed or intended to provide shelter or accommodation for the purpose of overnight stay within the Restricted Area without prior express consent of the owner or person in lawful control of the land, proof of which shall lie with the person remaining in any such vehicle, caravan or other temporary structure.
- If instructed to do so by an Authorised Person a person with responsibility for or utilising any vehicle or temporary structure shall remove the same and / or any associated equipment, animals or paraphernalia from the Restricted Area without delay.

As an example a clear breach of measure 7 would be that a vehicle is positioned for the purpose of overnight stay and that they do not have the prior express consent of the owner or person in control such as FHDC, KCC or other land owners.

2. Enforcement

In terms of enforcement we have a number of options when we are able to request that a person leaves the area/moves on with immediate effect.

We are able to issue a warning which can be either immediately or within a certain period of time, depending on the situation and severity (see Appendix 2), or we can go straight to the issue of a, Fixed Penalty Notice (FPN).

FPNs are designed to give an offender the opportunity to discharge any liability to conviction for an offence - which means that by admitting the offence and paying the penalty notice, an offender can avoid being prosecuted further for the offence.

The FPN is fixed at £100. The offender should make the full payment of £100 within 14 days as failure to do so will result in their case being passed to the Legal Team for further action to be taken.

There is no formal appeal process for FPNs – if you disagree that you have committed an offence, you can decide not to pay the penalty notice and the matter will be dealt with at Court.

3. Areas covered by the PSPO

The PSPO applies to the restricted areas within the boundaries of the maps covering the district. Please note some measures are to specific areas which need to be referenced to the schedule in the final Order (see Appendix 3). Schedule below –

Other than St Mary's Bay, Dymchurch and Hythe, Measure 7 is across the majority of the district.

It is important to note that it would not be advisable to have a blanket district-wide PSPO on measure 7 as the Courts may consider it to be unfair and rule against it completely should any case be taken to Court and overturn the PSPO.

Legal advice was obtained from a Barrister, David Armstrong, who warned that listing specific areas or roads would be more advantageous to ensure the PSPO could not be challenged in Court, as it allowed for the right to travel.

Public Spaces Protection Order (PSPO) Warning under the Anti-social Behaviour, Crime and Policing Act 2014

Measure 7 of the Order (Unauthorised Camping), creates an offence where a person positions any vehicle, caravan, tent or other temporary structures that are designed or intended to provide shelter or accommodation for the purpose of overnight stay within the Restricted Area without prior express consent of the owner or person in lawful control of the land, proof of which shall lie with the person remaining in any such vehicle, caravan or other temporary structure. This measure applies to all land and highways, owned, under the control of, or operated by The District Council of Folkestone and Hythe and Kent County Council and any privately owned land forming part of the Restricted Area as defined by the Order.

This letter is a formal warning from Folkestone and Hythe District Council that you may be committing an offence under section 67 of the Anti-social Behaviour, Crime and Policing Act 2014. The maximum penalty on conviction for an offence under this legislation is a fine not exceeding £1,000.

Please do not ignore this letter. You must take the appropriate steps to ensure that you are not in breach of the Order immediately. Should any further breaches be identified Folkestone and Hythe District Council may take formal enforcement action including a Fixed Penalty Notice in the sum of £100 or the commencement of criminal proceedings.

The Anti-social Behaviour, Crime and Policing Act 2014 The Public Spaces Protection Order - (Folkestone & Hythe District Council) 2019 – 2021

Folkestone & Hythe District Council (the "Council") makes this Public Spaces Protection Order (the "Order") in exercise of its powers under Section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 (the "Act"). This Order may be cited as the Folkestone & Hythe District Council Public Spaces Protection Order 2019 -2021.

The Council is satisfied on reasonable grounds that the activities described below (the "Activities") carried out in a public place within its area have had, or are likely to have, a detrimental effect on the quality of life of those in the locality and that the effect of the Activities –

- a) Is, or is likely to be, of a persistent or continuing nature
- b) Is, or is likely to be, such as to make the activities unreasonable, and
- c) Justifies the restrictions imposed by the Order.

This Order applies to any land to which the public has access within the areas outlined in red on the maps which accompany the order (the "Restricted Areas") as listed in Schedule 1 below.

The restricted area does not and shall not include any area of land in so far as it is already governed by existing byelaws within the district.

This Order comes into force on Friday 21 June 2019 for a period of 3 years, with an initial review after 1 year.

The Activities which are prohibited or required by this Order are:

1. Anti-social alcohol consumption

Where a constable, police community support officer or duly authorised officer of the Council (hereafter "Authorised Person") reasonably believes that the consumption of alcohol in a Page 17

Restricted Area has had, or is likely to have, a detrimental effect of the quality of life of those in the locality they can require any person:

- (a) Not to consume alcohol or anything which they reasonably believe to be alcohol;
- (b) To surrender anything in any person's possession which is, or which the Authorised Person reasonably believes to be, alcohol or a container for alcohol.

Any surrendered items may be disposed of by the Authorised Person in any way he or she thinks is appropriate.

An Authorised Person who imposes a requirement under 1(a) or 1(b) above must tell the person that failing without reasonable excuse to comply with the requirement is an offence.

A person who fails without reasonable excuse to comply with a requirement imposed on him or her under 1(a) or 1(b) above commits an offence and is liable on summary conviction to a fine not exceeding level 2 on the standard scale.

A requirement imposed by an Authorised Person under 1(a) or 1(b) above is not valid if when asked to show evidence of his or her authorisation they fail to do so.

Exemptions - This provision does not apply to alcohol being consumed within premises (including designated outdoor areas) that have obtained a license under the Licensing Act 2003 or section 115E of the Highways Act 1980.

2. The use of intoxicating substances

- a) The ingestion, inhalation, injection, smoking or other use of psychoactive intoxicating substances shall be prohibited in Restricted Areas.
- b) Where an Authorised Person reasonably believes that psychoactive intoxicating substances are being ingested, inhaled, injected, smoked or otherwise used in a Restricted Area they will require any person to surrender said substance and any associated items.

The requirement under paragraph 2(a) and 2(b) above shall not apply where the substance:

- i. Is used for a valid and demonstrable medicinal or therapeutic purpose:
- ii. Is a cigarette or pipe (tobacco) or vaporiser:
- iii. Is a food product regulated and not prohibited by food, health and safety legislation

3. Urinating, spitting or defecating

No person shall urinate, spit or defecate in Restricted Areas other than by use of a lavatory made available for use by the public.

4. Begging

- a) All persons are prohibited from approaching other persons in order to beg them for money;
- b) All persons are prohibited from sitting or loitering whilst in possession of signage or other items ancillary to, and for the purposes of, begging or soliciting money from passers-by.

Exemptions - These prohibitions do not apply to any authorised collections made on behalf of registered charities or other approved organisations.

5. Anti-social street entertainment

a) No person shall perform any type of street entertainment in such a way that causes a nuisance to nearby premises or members of the public. Such nuisance includes but is not limited to the inconsiderate obstruction of highways, footpaths and shop entrances.

No person shall continue to perform any type of street entertainment when directed by an Authorised Person to cease that activity.

6. Unauthorised street fundraising and marketing (Chugging)

A person shall not stop or approach another person for the purpose of asking them to:

- a) subscribe or to donate to a charity;
- b) participate in a marketing questionnaire or survey
- c) A person shall not encourage any person to do anything which would constitute a breach of a) and b) above.

Exemptions – Paragraph 6 above is not applicable where the Activity has been authorised by the Council or other body in accordance with a scheme operated or expressly approved by them.

7. Unauthorised camping

a) No person shall position any vehicle, caravan, tent or other temporary structures that are designed or intended to provide shelter or accommodation for the purpose of overnight stay within the Restricted Area without prior express consent of the owner or person in lawful control of the land, proof of which shall lie with the person remaining in any such vehicle,

caravan or other temporary structure.

b) If instructed to do so by an Authorised Person a person with responsibility for or utilising any vehicle or temporary structure shall remove the same and / or any associated equipment, animals or paraphernalia from the Restricted Area without delay.

Offence of failing to comply with Order

Under Section 67 of the Act:

- 1) It is an offence for a person without reasonable excuse—
- a) To do anything that the person is prohibited from doing by a public spaces protection order, or
- b) To fail to comply with a requirement to which the person is subject under a public spaces protection order.
- 2) A person guilty of an offence under this section is liable on summary conviction to a fine not exceeding level 3 on the standard scale, except for anti-social alcohol consumption which will not exceed level 2.

Summary: This report updates Members on the identified schemes approved for construction

1. Introduction

This report provides an update and summarises schemes that have been programmed for delivery in 2020/21

Kent County Council has agreed a substantial increase in the budget for planned highway works over the next three years, and as a result we are still in the process of identifying and designing schemes for inclusion in our full Year One to Two (2020/21 and 2020/21) and Year Three to Five (2021/22 to 2023/24) programmes. Because of this, we have decided to publish an interim programme, and to publish the full programmes later this year. For some assets this interim programme covers approximately the first six months of 2020/21, whilst for others it includes most of the works planned for the whole year.

This programme is subject to regular review and may change for a number of reasons including budget allocation, contract rate changes, and to reflect KCC's changing priorities. The programme and extent of individual sites within the programme may also be revised following engineering assessment during the design phase.

Road, Footway & Cycleway Renewal and Preservation Schemes – see Appendix A

Drainage Repairs & Improvements – see Appendix B

Street Lighting - see Appendix C

Transportation and Safety Schemes – see Appendix D

- Externally funded schemes

Local Growth Fund

Local Growth Fund programme update for the Folkestone & Hythe District.

The Department for Transport (DfT) added £100m to the Local Growth Fund (LGF) pot in order to fund Local Sustainable Transport Fund Style schemes. KCC subsequently submitted four Local Sustainable Transport Fund (LSTF) capital bids 1) East Kent – A network for Growth, 2) Kent Thameside – Integrated door-to-door journeys and 3) West Kent – Tackling Congestion. The fourth was for Tonbridge Town Centre Regeneration, which included a highway improvements scheme in the Lower High Street as well as additional LSTF style measures. The objective of all the capital bids is to boost economic growth by decreasing carbon emissions and reducing congestion.

The Kent Thameside, West Kent and Tonbridge Town Centre Regeneration bids were all successful. The schemes aim to:

- improve access to employment and services
- reduce the need to travel by the private car
- enhance pedestrian, cycle and public transport facilities
- improve sustainable transport connections

Summary: This report outlines the arrangements that have been made between Kent County Council and Folkestone & Hythe District Council to provide a local winter service in the event of an operational snow alert in the borough/district

1. Introduction

- 1 (1) Kent County Council Highways, Transportation & Waste (KCC HTW) takes its winter service responsibilities very seriously and is proactive as well as reactive to winter weather conditions. Winter service costs KCC in the region of £3.3m every winter and needs careful management to achieve safety for the travelling public and to be efficient. The Highways Operations teams in HTW work to ensure that the winter service standards and decisions made are consistent across the whole county.
- 1(2) HTW prepares an annual Winter Service policy and plan which are used to determine actions that will be taken to manage its winter service operations. The policy was presented to the Environment and Transport Cabinet Committee on 15th September 2020 and subsequently approved by the Cabinet Member.

2. District based winter service plans

- 2(1) The Local Winter Service Plan for the Folkestone & Hythe District is a working document which will evolve and be revised as necessary throughout the year. This document complements the KCC Winter Service Policy and Plan 2020/21.
- 2(2) Following successful work in previous years with district councils, arrangements have again been put in place this year whereby labour from district councils can be used during snow days. Additionally, HTW will supply a quantity of a salt/sand mixture to district councils to use on the highway network. The details are contained in the plan which enhances

the work that HTW will continue to do in providing a countywide winter service. The local plan comes into effect when a snow emergency is declared that affects the district of Folkestone & Hythe.

3. Pavement clearance

3 (3) Areas for clearing pavements have been identified in the local plan. These are the areas where local knowledge has indicated that people are concerned and would most like to be kept clear when there is snow and ice.

4. Farmers

4(1) The work that our contracted farmers have done in recent years is greatly appreciated and has made a big difference in keeping rural areas clear on snow days. Again, this year farmers will have predetermined local routes and will use their own tractor and KCC ploughs for clearing snow. The ploughs supplied are serviced by KCC each year. Each farmer will have plans detailing the roads that that they are responsible for ploughing. When snow reaches a depth of 50mm on roads in their areas the farmers will commence ploughing notifying KCC as agreed in their contract. A list of farmers and their contact details can be found in the local plan, (although some personal information will not be available via this report or the website due to General Data Protection Regulations).

5. Conclusion

5(1) Working in partnership with the district councils will enable HTW to provide an effective winter service across the county.
