To provide safer cycle routes in Folkestone, focusing on increased permeability from the schools cluster to both train stations and the harbour.

PROJECT DESCRIPTION:

There is an identified need for cycle routes to link the schools cluster (Morehall) of Folkestone with the town.

There appears to be few options within the current road structure to design a dedicated route through the residential streets from Cheriton High Street to the schools. On road provision would be made safer by 20mph speed limit in the area. A second phase of the scheme could look at the potential to convert the existing footpath from Harcourt Road to Chart Road. The path would need to be widened to a minimum of 2.5m. The land either side belong to Morehall Primary School. This is shown on the attached map.

There is a cluster site for pedal cycle crashes at the junction with Cheriton High Street so this junction would need to be addressed as a priority as part of the overall scheme. Reviewing the types of pedal crashes it could be inferred that most have occurred by cyclists not feeling confident crossing the junction (either using the footway or jumping the lights) see attached D Print. There is also a cluster of motorcycle crashes at that junction. Further analysis is needed but a possible option would be advanced cycle lanes.

There are several developments in the area coming forward. Discussions have not yet taken place regarding whether developer funding could be used to supplement LTP funding but Shorncliffe Garrison (for up to 1,200 residential units) would certainly benefit from the new proposed route. There is also a new development coming forward near the harbour. There is some developer funding assigned for improvement works at the Cheriton High St/Beachborough/Cherry Garden Ave junction from the seafront and Shorncliffe applications to increase capacity. At this stage I am unsure if the proposed improvements will improve safety for cyclists due to the focus on increased capacity. There is also a right turn proposed for vehicles out of Cheriton High St. before Junction 12 using developer funding.

The train line through Folkestone currently poses a barrier to cycle routes so we have identified possible routes through as well as the best options to cycle to both stations. Improved links to Folkestone Central should be a priority as this is the main station for visitors due to the High Speed line.

All sections of phase 1 (with the exception of a small stretch by the Civic Centre) are within the highway boundary according to Kent View. The proposed route has been selected to best follow desire lines as well as giving the most options to improve the route for cyclists within the current boundaries.

SPECIAL DESIGN CONSIDERATIONS:

The scheme is to meet recommended guidance from the Department for Transport (e.g. LTN 02/08), Manual for Streets and Kent Design Guide. Departure from these standards is to be explained, although we would advocate reference to the recent Sustrans Design Manual (April 2014) and the Cycling England archive.
