

The Kent County Council
(The District of Folkestone & Hythe, various Roads)
(Restrictions and Prohibitions of Waiting, Loading and Unloading)
Order 2021 (Amendment No 21).

Notice is hereby given that KENT COUNTY COUNCIL has made the above Order under sections 1(1), 2(1) to (3), 3(2), 4(1) and (2), 32(1), 35(1), 45, 46, 49 and 53 of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act:

PROHIBITION OF WAITING AT ANY TIME

Ashley Avenue, Folkestone: Removing a 33 metre section of yellow line opposite Mildred Cottages to allow parking; **Morehall Avenue, Folkestone:** North side of junction with Surrenden Road to match opposite side; **Tudor Road, Folkestone:** North Side from the junction with Weymouth Road for a distance of 161 metres;

West Hythe Road and Lympe Hill, West Hythe: Both sides from a point outside and opposite the boundary of 'Cleveland' and 'The Maples' for a distance of 138 metres on the west side and 146 metres on the east side in a north easterly then northerly direction;

Coast Drive, Lydd on Sea: To introduce 45 metre sections of double yellow lines between The Lade car park and the Pilot Inn;

Canterbury Road, Lyminge: North east side from 2 Berkeley Villas for 45.5 metres in a south easterly direction;

Sussex Road, New Romney: From the junction with West Street for 67 metres and from the junction with Spitalfield Lane for 42 metres;

Prospect Road, Sandgate: Both sides at the junction with Sandgate Esplanade for 10 metres;

PROHIBITION OF WAITING AT ANY TIME ON VERGE OR FOOTWAY

Dymchurch Road, Hythe: Both sides from Jubilee Close to the Bluewater Caravan Park entrance.

Full details are contained in the draft Order which, together with the relevant drawings, a copy of any orders which will be amended by the proposed Order, and a statement of the Council's reasons for proposing to make the Order may be examined at The Council Offices, Castle Hill Avenue, Folkestone or on our website.
