### 9. **Minutes of the Licensing Sub-Committee**

### 10. **20/1212/FH - Land rear of 2 Willop Close, Dymchurch, TN29 0HU**

Erection of 2 three-bedroom dwellings and associated parking.

This application was withdrawn from the agenda and would be reported to a future meeting.

11. **20/1356/FH - Hillboro, Sunnyside Road, Sandgate, Folkestone, CT20 3DR**

Proposed 4no new dwellings and associated external areas within the curtilage of Hillboro (proposed to be demolished) and accessed from Sunnyside Road via a new private shared drive.

**RESOLVED:**

**(i) That an Enforcement Notice be served under Section 38 of the Listed Buildings Act requiring the removal of the shopfront and the installation of a wooden framed shopfront of the same design and appearance as the one that has been removed and plate glass windows.**

**(ii) That an Enforcement Notice be served under Section 72 of the Town and Country Planning Act requiring the removal of the shopfront and the installation of a wooden framed shopfront of the same design an appearance as the one that has been removed and plate glass windows.**

**(iii) That the Chief Planning Officer be given delegated authority to determine the exact wording of the Notices.**

**(iv) That the period of compliance with the Notices be (twelve) 12 months.**

**(v) That the Assistant Director - Governance, Law & Regulatory Services be authorised to take such steps as are necessary, including legal proceedings, to secure compliance with the Notice.**
