#### 74. 21/2178/FH - 6A, 6B, 8A and 8B Defiant Close, Hawkinge, Folkestone, CT18 7SU

Alterations and change of use of 6A, 6B, 8A and 8B Defiant Close from commercial uses (Classes A1, A2, A3 and B1) to residential (Class C3) creating 6 no. apartments.

## 75. 21/1493/FH - Folkestone Harbour, Harbour Approach Road, Folkestone, CT20 1QH

### 76. 21/1492/FH Folkestone Harbour, Pedestrian Area, The Stade, Folkestone CT20 1QH

Erection of 6 pitches to be used by mobile units along with electric cabinets for power supply.

Councillor Mary Lawes, spoke against the application on behalf of Folkestone Town Council. Mr Paulo Kingston-Correia, the applicant spoke on the application.

Proposed by Councillor Jim Martin Seconded by Councillor Jackie Meade, and

#### **RESOLVED**:

That planning permission be refused on the grounds that (i) the application would bring about an unacceptable increase in obstruction to pedestrians on The Stade, with consequent harm to users of the highway. (ii) The application would have an unacceptable impact on residential amenity by virtue of smells and cooking odours; and (iii) The establishment of these food outlets would harm the special character of the conservation area.
